## Universal Community Trust - Information and Welcome Pack

This document is for those interested in joining the Universal Community Trust (UCT). The additional documents you will need to refer to are highlighted in yellow.

Please read **UCT-2 'Treaty of the Universal Community Trust'** (find out more at: <https://www.universal-community-trust.org/>). When you join UCT, either as a trustee or a beneficiary, you will be pledging yourself, and the trustees and beneficiaries of your UCT Trusts, to live by the guiding principles of Natural Law, as set out in the UCT Treaty.

UCT is an umbrella Trust, under which sit all the indigenous and sovereign Anarcho-Nations [AN], also known as Sovereign Community Trusts [SCT] or Anarcho-Trusts [AT].

Under each of these nations are numerous Family Trusts/Private Trusts (with their own trustees and beneficiaries), which will essentially be beneficiaries of the Anarcho-Nations/Sovereign Community Trusts. See **UCT-3 'UCT Summary Graphic.'**

### Join the UCT in five steps:

#### ***Step 1: In ALL cases, declare your Family Trust/Private Trust:***

- The first step is always to declare your Family Trust (FT) or Private Trust (PT). Use **UCT-4 'Example Family Trust A4 size'**, which must be edited with your and your family's/associate's details and the property/items to be protected by the Trust in **Schedule A**. See **UCT-4a 'Family Trust Notes/Helpsheet'** to help.
- The Trust deed must be signed by the grantor-trustee and any other founding-trustees (copy and paste spaces if more signatures needed), and then witnessed by TWO witnesses.
- Your FT/PT document is private to you and your beneficiaries, and the UCT does not need a copy.

#### ***Step 2: Check UCT-5 'UCT Map SCTs'. If there is already an SCT in your area/near to you/in your country, you will need to apply to the SCT trustees in order to join them as a beneficiary FT/PT under their existing AN/SCT:***

- There will be eligibility criteria/security checks. Once approved, this means your FT/PT will become a beneficiary of the existing SCT/AN, along with other

families/groups in this community (you do not need to be living in the geographic area to do so). **Once you've contacted the SCT and your FT/PT has been approved to join them, skip to Step 4.**

***Step 3: Only if you have been invited to do so by the UCT, and/or subject to certain conditions, you can apply to become a trustee of an existing SCT/AN, or declare a new SCT/AN under UCT and become trustees of the new SCT/AN:***

- **If there is already an AN/SCT in your geographic area but without trustees** due to resignation or breach of trust of previous trustees, and if invited to do so, you can apply to UCT to become a trustee of that existing AN/SCT. You and your fellow trustees will need to sign **UCT-8 'New Trustees Pledge annex'** with TWO witnesses. Then you'll take over as the trustee(s) of the existing AN/SCT.
- **If there is no existing AN/SCT in your country**, and if invited to do so, you can declare a new AN/SCT for a specific geographic area. This means you will become a grantor-trustee or founding-trustee of the new AN/SCT. Read **UCT-6 'Setting up new AN/SCT Guidelines and Checklist'** first. Then you and the other founding trustees will need to sign **UCT-7 'AnarchoTrust/SCT Declaration new'** with TWO witnesses.

**Note: Step 3 options require that you and your fellow potential trustees are first approved by at least two UCT founding trustees, with no objections from all other UCT founding trustees, and that you pass eligibility criteria/security checks.**

***Step 4: In ALL cases, all trustees of your FT/PT must sign one 'Affirmation of the Beneficiaries' document per FT/PT, with SCT trustees, in order to join UCT:***

- This document links your FT/PT to an AN/SCT under UCT. Once you've completed your FT/PT docs, no matter which pathway to joining UCT, you will need to sign one **UCT-9 'Affirmation of Beneficiaries'** document per Family Trust/Private Trust. It must be signed by all trustees of the FT/PT, any beneficiaries of the FT/PT aged 16+ years, **at least two trustees of the AN/SCT you will be part of**, and TWO witnesses.

***Step 5: Submit documents and receive confirmation of joining UCT:***

- Follow '**UCT Virtual Deed Signing Process**' if you cannot sign/witness in person.
- The relevant signed and witnessed documents (the **AN/SCT Declaration** or **New Trustees Pledge**, as relevant, **and/or Affirmation of Beneficiaries** document must be submitted to UCT Admin in order for you and your Trust, and the trustees and beneficiaries of your Trust(s), to fall within UCT jurisdiction.

- **Note:** In ALL cases, you will **not** be considered to have joined UCT until all paperwork has been submitted, acknowledged as received and all correct by UCT Admin, sealed by UCT, and this has been confirmed back to you by UCT Admin.
