

UCT Joining Process - Emails Checklist and Records Needed

Before you do anything else: Subscribe to the Join-UCT email subscriber list at: <u>https://www.universal-community-trust.org/join-uct/</u> (this is essential, because it's here you will have access to all the documents referred to below, as well as instructions and explanations you'll need to join the UCT).

If you've already done that and have received all 9 Join-UCT emails, then use the checklist below to ensure you've completed all steps and paperwork correctly and you have the necessary records ready to send to UCT Admin for confirmation.

UCT 3	Check that you have completed your Family Trust/Private	
	Trust properly, including who can be trustees and	
	beneficiaries, and responsibilities of trustees.

	size.doc, UCT4a-Family-Trust-Notes-Helpsheet.pdf and	
	UCT Virtual Deed Signing Process.pdf again.	
UCT 4	Understand what a Sovereign Community Trust	
	[SCT]/AnarchoNation [AN] under UCT is.	
	Read about Benefits of joining UCT at UCT website.	
	Check UCT5-UCT-Map-SCTs.pdf and UCT5a-SCT-	
	contact-details.pdf so you know where existing SCTs are,	
	then contact nearest one to ask to join them.	
UCT 5	Understand the different options for joining or declaring an	
	SCT/AN under UCT.	
	If relevant, learn how to set up new SCT - download

	Signing Process.pdf again.	
UCT 8	Understand what Affirmation of Beneficiaries means.	
	Download UCT9-Affirmation-Beneficiairies-FT-to-	
	SCT.doc (SCT must edit with details of SCT/AN trustees,	
	FT/PT trustees and FT/PT beneficiaries, both you and	
	they must sign, and have it witnessed, then both of you	
	should keep for your records). ** This document must	
	be sent to UCT by SCT trustees – see email 9.**	
UCT 9	Understand which records must be sent to UCT, and the	
	confirmation process from UCT that you have joined.	
	Download UCT-Joining-Process-Emails-Checklist.pdf (this	
	checklist) to ensure all paperwork and processes are	
	correct.	
	Read UCT1-Greetings-UCT.pdf which lists the processes	
	and where to send documents for confirmation.	
	Send to UCT Admin copies of the relevant edited, signed	
	and witnessed deed documents for their records.	
	Read UCT FAQs and/or contact UCT via UCT website if	
	any queries.	
	Await confirmation from UCT Admin on your joining	
	status.	

Please note: In all cases, you will <u>not</u> be considered to have joined UCT until all paperwork has been submitted, acknowledged as received and all correct by UCT Admin, processed/sealed by UCT, and this has then been confirmed back to you.
